TERMS AND CONDITIONS

The price is for erection, hire and dismantling of scaffolds only and does not include encapsulation. Under the Australia Standards Regulations, all wrapped scaffolds require Engineering. All Engineering costs, including site visits, have not been included in this quote and are at additional cost if deemed necessary.

Any alterations required to the scaffolding; need to be confirmed in writing and will be charged for at applicable man-hour rate and must only be undertaken by employees of Adam's Scaffolding Services Pty Ltd. Normal working hours allowed only. Any additional materials needed charged for at list price. Our Ordinary Hours rate is \$65 p/hr p/person for all Adam's Scaffolding Services Pty Ltd Employees. Overtime is charged at a flat rate of \$86 p/hr p/person and public holidays are to be negotiated at the time. Labour begins and ends in our yard, each day.

All scaffolds that are up for a period of 1 month, or more, will require a safety inspection, by us, in accordance with Australian Safety Standards, or more often, will some site regulations. This will be charged at cost.

Scaffold Hire begins when scaffold leaves yard and ends when scaffold is returned to the yard. Initial scaffold hire is a minimum of 2 weeks and scaffold is hired out on a weekly basis thereafter.

Delays onsite for example, waiting time, wet weather, etc. will be charged at applicable man-hour rate.

Cranage, forklift, traffic management requirements, safety fencing, fire protection, atco hut and amenities including tearooms and toilet facilities at site cost and by site arrangements.

Damaged or lost material charged for at replacement cost.

External truck hire is charged at cost. Local area only transport (Adam's Trucks) is charged at \$160 p/trip.

Extra materials will incur a 10% handling fee.

Site induction's, both external and internal, will be charged at applicable man-hour rate.

One day's notice, is required, if Adam's Scaffolding Services Pty Ltd representatives are required to attend site meetings.

GST, will be in addition to these prices, unless stated otherwise.

Our scaffolds are build to Australian Standards: AS/NZS 1576.1.2010

We work under the Work Health & Safety Regulation's 2012 Act and the Building and Construction General On-site Award 2010.

We require, a signed Purchase Order, before work commences.

Payment terms 30 days from invoice.

Upon receipt of your invoice, you have 7 days to contact administration of Adam's Scaffolding Services Pty Ltd, in writing with any discrepancy, or the invoice will be deemed true and correct and payment will need to be paid in full.

If we are successful in winning the quote; we require a start date, at the earliest possible time, to prevent delays, with the scheduling of the work, materials, engineering etc.
